# **VOLINIA TOWNSHIP**

CASS COUNTY, MICHIGAN Minutes of Regular Meeting Monday, April 14, 2025 6:30pm

The meeting was called to order by Supervisor Chris Brooks at 6:30pm.

Prayer was given by Denny Grice.

The Pledge of Allegiance was led by Chris Brooks.

Annette Peters requested roll call: Trustee Grice – Present, Trustee Seelye – Present, Treasurer Williams – Present, Supervisor Brooks – Present, Clerk Peters - Absent.

## **Agenda**

The agenda was present. Annette Peters said that approval of the February and March Treasurer's reports needs to be added, if they are ready. Chris Brooks made a motion to approve the agenda with the addition of the February and March Treasurer reports; Denny Grice seconded the motion; all in favor; motion passed.

## Minutes

The minutes from the last regular meeting, March 10, 2025, were presented. Alex Williams made a motion to approve the minutes; Chris Brooks seconded the motion; all in favor; motion passed.

The minutes from the Budget Hearing, March 20, 2025, were presented. Chris Brooks made a motion to approve the minutes; Denny Grice seconded the motion; all in favor; motion passed.

Zoning Administrator Report – Land Divisions applications. Application for Pergola. Provided Clerk with information for FOIA. Met with property owner about dilapidated home. Met with property owner about someone living in camper.

Building Inspector Report - No Activity.

OMA Violation – Investigation has been denied by prosecutor.

MTA Convention – Was attended by Chris and Beth. They learned a lot of information. No charges for attending or hotel to the township.

## **Treasurer's Report**

The February Treasurer's report was presented with a balance of \$226,014.24 in the general fund. Balances in the other funds are as shown. Alex Williams said that the \$0.03 discrepancy in the tax account that he is still trying to figure out. Annette Peters asked if there were no deposits for the whole month of February. Chris Brooks questioned the road fund balance. Annette Peters made a motion to approve the February Treasurer's Report; Chris Brooks seconded the motion; all in favor; motion carried. Chris Brooks requested a roll call vote:

## Bills

The April bills were presented with a total of \$49,722.61. Alex Williams made a motion to pay the April Bills as listed; Chris Brooks seconded the motion; all in favor; motion carried. Annette Peters requested a roll call vote:

#### Clerk

Annette Peters made a motion to take advantage of Election Source's ICP 1 Trade-It offer to upgrade to an ICP 2 tabulator and receive a \$1,000 credit; Chris Brooks seconded the motion; all in favor; motion carried. Chris Brooks requested a roll call vote:

#### **Trustee Grice**

Cemetery digitization progress – Currently working on computerizing the last cemetery, should be done in the next 2 weeks. Then mapping will start, probably from the 1<sup>st</sup> part to mid part of May.

PC Consultants – Denny Grice made a motion to hire a specialist to do a traffic impact study along the haul route from the trucks heading west and east from the proposed mining site; Annette seconded the motion; Chris asked if CCRC has looked at these routes as they have road engineers on staff, and if we are going above them, Randy Cuthbert said before the SUP was submitted there was a meeting with CCRC, during hearings they said the routes would not work, then at the next hearing they said it was the route the truck had to take. All in favor; motion carried. Chris Brooks requested a roll call vote:

The board approved to hire a specialist to do a traffic impact study along the haul routes.

Denny Grice made a motion to hire a specialist for a ground water study. Williams and Works would subcontract a geologist or hydrologist for further ground water study for both quantity and quantity of water. Annette Peters seconded the motion; Chris Brooks said that he hasn't received qualifications but hopes no more studies will be requested from the PC after this. All in motion, motion carried. Chris Brooks requested a roll call vote:
